ELIGIBLITY

- 2. Entry is only open to residents of NSW, Australia and in the event that their entry is drawn as the winning entry for the Sydney Kings vs LA Clippers in Hawaii Competition, is able to participate in the prize as set out below (**Entrant**).
- 3. - 6.
